#### Our Vision

...is for children who come into care in the State of Tennessee to have the same advantages and opportunities as those children who do not experience the foster care system.

#### **Our Mission**

...is to help Foster Parents feel they are not alone. We motivate and support them to keep them fully engaged in the fostering community. It is also our Mission to recruit and retain Foster Parents.

TFACA is passionate about bettering the lives of foster children in Tennessee. We know that supporting the Foster Parents who parent those children is paramount in the success of each placement.

TFACA works closely with DCS to support their work to educate, support, and retain Foster Parents across the state. We encourage and motivate foster and adoptive parents, as well as any other interested member of the community, to work together to promote the general welfare of foster children We assist in communication between foster and adoptive parents and others concerned with the growth and development of foster children. We serve as spokespeople for foster and adoptive parents and the children under their care and custody in Tennessee.

In our work with local associations, TFACA has the infrastructure in place to support Foster Parents across our state. TFACA presence across the state allows us to identify trends and provide programs and services to address issues our Foster Parents are facing. With a commitment to strong partnerships to benefit Foster Parents, we work alongside them to address and resolve problems as well as seize opportunities to help our foster children grow. Our partners, among others, include local associations, the Department of Children's Services, and Tennessee Community Services Agency.

Active members must pay annual dues and have the right to vote and be eligible for election as officers or directors of the TFACA. Funding for operations also comes through a contract with the Department of Children's Services, Tennessee Employees Charitable Campaign, individual and corporate donors, and through a series of "Walk Me Home" annual walks operated under the umbrella of the national Walk Me Home.

# Tennessee Department of Children's Services:

#### Foster Care in Numbers

- 625 new foster homes approved as of June 30, 2017

Every DCS and Private Agency Foster Parent has the right to Advocate support and representation. The **Advocacy Program** offers trained and experienced Foster Parents to assist in advocating on behalf of other Foster Families in times of need. Advocates are available to answer questions, assist with concerns, and provide representation in order to protect and support Foster Parents and promote the safety and well-being of children. Advocates serve in one of

twelve Department of Children's Services regions throughout
Tennessee and also serve Foster Families should they be in need
of representation during a SIU, Special Investigation. During this
fiscal year Advocates fielded over 14,000 calls, emails, and texts.
They also appeared over 1,240 times at Department of
Children's Services meetings and court hearings to support
foster/kinship parents and assisted with 591 SIU inquiries.

TFACA is committed to serving our foster families well through education and experienced advisors. The **Mentorship Program** recruits, supports, and seeks to retain good Foster Parents. The goal of this program

is to partner new Foster Parents with seasoned ones to offer support and expertise. Understanding the foster care system and the role of the Department of Children's Services can be daunting. Mentors understand the various processes and can be an invaluable resource to new foster families. Led by TNCSA and the TFACA Regional Directors, the Mentorship Program is the place for foster families to gain confidence in their work with foster children. Almost 448 mentor/mentee matches were made in 2017-2018, an increase of 54 from the previous year. In addition, 52 new mentors were trained in 2017-2018.

The **Kenneth and Maxine Fox Scholarship Fund** is awarded each year to eligible foster children and/or eligible birth/adopted children of TFACA members. The scholarship is funded by the silent auction held at the Tennessee Foster Parent Annual Conference.

The Walk Me Home Enrichment Fund offers a source of funding for extracurricular activities for foster

children. TFACA wants all Tennessee foster children to have opportunities to grow, learn, have fun and express their unique self. The fund has covered athletic registrations, camps, musical instruments and a variety of lessons. TFACA hosted three 5K walks across Tennessee this year to educate others about fostering issues and raise donations for the Fund. Over \$12,000 was awarded to foster children, an increase of 50% of the previous year. This



year, TFACA was awarded the National Foster Parent Association's 10 Year Participation Award.

## Building and supporting local associations in their area

Local associations provide a forum for foster parents to obtain direction, education and support. The Regional Directors attend the local association meetings in their area and support, encourage and motivate in an effort to retain good foster parents across our State.

### Educating and motivating foster parents

Regional Directors inform our foster parents about changes in policy, programs and other pertinent information, keeping them current with changes in the system. This is done at the local level and through our Newsletter, "The Foster Parent Connection".

### Participating in and coordinating our Mentorship program

Regional Directors work with TNCSA and the Department of Children's Services to identify seasoned foster parents who are able to mentor new foster parents in their walk through the process of fostering.

#### Walk Me Home Event Coordination

The Walk Me Home Enrichment Fund helps foster children and youth with extracurricular activities and special needs. The Regional Directors work alongside TFACA to coordinate the 5K walk in their area, benefitting the Walk Me Home Enrichment Fund.
