TFACA's Role in Foster Care

TFACA is passionate about bettering the lives of the foster children in Tennessee. We know that supporting the Foster Parents who parent those children is paramount in the success of each placement. We are committed to, and recognize the importance of Foster/Adoptive Parents and we are the spokespersons for them and the children under their care.

With local associations under our umbrella, TFACA has the infrastructure in place to support Foster Parents across our great state. Our Regional Directors are entrusted with the tasks of supporting the local associations and Mentorship Program in their region. Our Advocacy program provides support as needed when our families are in crisis or under a SIU. TFACA presence across the state allows us to identify trends and through programs and services address issues that our Foster Parents are facing. With a commitment to strong partnerships to benefit Foster Parents, we work with them to address and resolve problems as well as seize opportunities. Our partners, among others, include our local associations, the Department of Children's Services, and Tennessee Community Services Agency.

About Foster Care

On any given day, there are approximately 397,000 children in foster care in the United States. In 2012, about 640,000 spent time in U.S. foster care. The average age of foster children is 9. Children remain in state custody for nearly two years on average and 9% are there for five or more years. In 2012, more than 23,000 young people aged out of foster care with no permanent home or family. These teens are more likely to become homeless, unemployed, a single parent and/or incarcerated as adults. (from Children's Rights 2014: www.childrensrights.org)

As of June 30, 2014, there were 8,008 children in Tennessee state custody. Of those, 2,350 were teens over the age of 16. There were 1,051 children in full-guardianship, but the majority were in pre-adoptive homes. Of the foster homes in Tennessee, 3,336 were DCS homes and 2,624 were private provider homes. The biggest challenge is securing homes for teens, larger sibling groups (3+ children), and homes in rural areas. (from John Johnson, Director of Foster and Adoption, DCS)

TNCSA is a public nonprofit, quasi-governmental agency created by legislation to respond to the needs of individuals, families and communities by coordinating and providing services across Tennessee under contract to state and local governments.

TFACA Programs

Tennessee Foster and Adoptive Care Association, Inc., committed to and recognize the *importance of foster/adoptive parents* in promoting the general welfare of our children. Our Advocacy Program began the same year that the Tennessee Foster Parent Bill of Rights became law, 1997. This law influences the way foster parents are treated in the State of Tennessee.

Advocacy

The Advocacy Program has been one of our banner programs. It is designed to help in times of crisis or special needs. The Advocates are highly trained experienced Foster Parents who are available to answer questions, assist with concerns that a Foster Parent may have, and advocate on their behalf. They receive specialized training to assist other Foster Parents in communicating effectively with their DCS family service worker. On those rare occasions when communications fails, Advocates will assist Foster Parents in filing grievances and appeals.

Currently, all 12 regions across the state have at least one Advocate who is available to the Foster Parents should they have questions about DCS policy and procedures or should they need representation in an SIU. Under the direction of TNCSA, the Advocates are independent of, but work in partnership with DCS and TFACA. Through TFACA's partnership with DCS and TNCSA, the Advocate program is paramount to promoting the general welfare of foster/adoptive families and the children they serve. It should also be noted that this program has been recognized outside of the State of Tennessee, and other States have modeled or adapted similar programs based on the work that was begun by TFACA in 1997.

Something new that was developed in 2015 for the Advocacy Program is a position call an Advocate Relations Specialist. This position is responsible for the public relations initiatives for the Advocacy and Mentorship Programs. The Advocate

Relations Specialist will work in conjunction with DCS, TFACA, and TNCSA to create, manage and implement PR activities with the goal of expanding statewide foster parents' knowledge of the Advocacy and Mentorship Programs. Our goal is to locate two qualified persons to fill this position by the end of 2015. Mentorship

The Mentorship Program is designed to guide new Foster Parents through the rocky waters of the DCS tidal wave, sort of like white water rafting! Despite the thrill of rafting there are always rocks lurking underneath the water. An experienced guide can maneuver around the rocks while allowing the "rafters" the pleasure of being on the water. Mentors basically do the same thing. They explain the pitfalls, heartaches, and joys of foster parenting and demonstrate proper ways to navigate the waters while enjoying the parenting process.

The goal of the Mentorship Program is to recruit, support and retain good foster parents by educating them, actively engaging with them and partnering as a Mentor. This program is available statewide for all new foster parents. Its' focus is to match new Foster Parents with seasoned Foster Parents who can help them understand the foster care system and how to best work with DCS. The Mentors develop relationships with the new Foster Families and help them to grow more knowledgeable and assured in parenting foster children. The more these families feel supported, the more likely they will have positive experiences in fostering and in turn will remain Foster Parents. Through Encouragement, Education and Support, parents gain a supportive resource in their Mentor, as well as competence. TFACA is committed to improving the knowledge and skills of the Foster Parents of Tennessee.



Led by TNCSA and the TFACA Regional Directors in each region, the Mentorship Program is the place for foster families to gain confidence in their work with foster children. As of September 2015, the Mentorship Program is fully operational in 6 regions. Training of mentors is taking place in the other 6 regions and will be fully operational by the end of 2015. There have been 102 foster parents trained as mentors since January 2015, and we hope to double that number in 2016.

Scholarships

The Kenneth and Maxine Fox Scholarship Fund is awarded each year to eligible foster children and/or an eligible birth/adopted children of TFACA members. The fund is a direct result of the money raised from the silent auction at each annual Conference. On average, 6 students receive a \$1000 scholarship each year. And this year we are awarding scholarships to 7 very deserving youth.



Enrichment Grants



The Walk Me Home Enrichment Fund directly impacts the lives of Tennessee's foster children by providing a source of funding for enriching activities and emergency needs, such as school trips, music lessons/instruments, athletic fees and therapeutic camps. TFACA hosts four 5K Walks across the state each year to educate the public about fostering issues and raise donations for the Walk Me Home Enrichment Fund. The 2015 walks raised over \$20,000 and TFACA has awarded over \$13,000 in Walk Me Home grants.



Nashville - The first walk of the year was again held at Bicentennial Mall. Our emcee, Teron Carter, did a great job. *Jaime Fox and the Desert Okies* provided music during the event. Rachel Rodriguez provided a wonderful children's program with her own music and Davidson Resource Linkage donated door prizes for all the children. The weather was beautiful and we had over 200 in attendance.



Chattanooga - Tennessee Riverpark – Hubert Fry Center was the location of this walk. The kids enjoyed popcorn, snow cones and face painting. Sandy Holder, RA for Tennessee Valley, was there to participate in the walk and hand out awards.



Memphis - Overton Park was the site for the west side walk this year. There was a DJ for music, ISNS Step Aside youth dance group and bounce houses for entertainment. Merlene Hyman, RA for Shelby Region, and Tammy Williams, Deputy RA, were in attendance and joined in the walk and the dancing. Great walk Memphis!

East – This was the first year that Springbrook Recreation Center in Alcoa was the venue for the East WMH event, and it was a wonderful success. There was a dunking machine, face painting, lots of donated food, lots of enthusiastic walkers and several vendors to fill the park. Kim Hansard from STAR 102.1 was on hand to emcee the day.

TFACA would like to recognize Blue Cross Blue Shield of Tennessee for their sponsorship of all four Walk Me Home events. The SelectKids program is vital to our fostering community and we appreciate BCBST's participation and support of Walk Me Home.

The TFACA Board is made up of the association officers and 12 Regional Directors, one for each Region recognized by the Department of Children's Services. These Directors have been charged with the following responsibilities:

Building and supporting local associations in their area

Local associations provide a forum for foster parents to obtain direction, education and support. The Regional Directors attend the local association meetings in their area and support, encourage and motivate in an effort to retain good foster parents across our state.

Educating and motivating foster parents

Regional Directors inform our foster parents about changes in policy, programs and other pertinent information, keeping them current with changes in the system. This is done at the local level and through our Newsletter, "The Foster Parent Connection".

Participate in and coordinate our Mentorship program

This program is fairly new to our support list for foster parents. Regional Directors work with TNCSA and the Department of Children Services to identify seasoned foster parents who are able to mentor new foster parents in their walk through the process of fostering. While this program has been rolled out in three regions, it will be moving across the state in the coming year.

Growth and Development

The Regional Directors are paramount in making sure that our foster families have the resources they need to support growth and development of the foster children of Tennessee.

Walk Me Home Event Coordination

The Walk Me Home Enrichment fund helps foster children with special things such as medical equipment not covered by TennCare, summer camps, band instruments, etc. The Regional Directors work with TFACA to coordinate a 5K walk in their area, benefitting the Walk Me Home Enrichment Fund.
